

Detailed Course Closure Impacts – Amgen Tour of California – Tuesday, May 14, 2019 – 2:45pm to 3:45pm



Area 1. Area North of Cochrane Road and East of Monterey Road

Access and egress is only available to this area by northbound Monterey Road. Since southbound Monterey Road will be closed, residents exiting northbound beyond Madrone Parkway on Monterey there will be no opportunity to turn (left) around until reaching Bailey Avenue during the course closure.

Area 2. Businesses West of Monterey Road on Cochrane Road (AM/PM & Starbucks)

During the course closure no access will be available. Egress will be available for customers to leave via Monterey Road South.

Area 3. Cochrane Village Apartments

During the course closure no vehicle access or egress will be available. Course marshals will be stationed at vehicle exits and may be able to provide limited egress during the closure period.

Area 4. Residences located off Jarvis Drive (Madrone Plaza)

Access during the event will not be available. Egress will be available exiting Monterey Road South.

Area 5. Businesses on Digital Drive

Access and egress will be unavailable during the event. Limited egress may be allowed by course marshals to Butterfield Boulevard north.

Area 6. Homes at Central and Butterfield (Valencia Homes)

Access and egress will not be available during the course closure from Butterfield Boulevard. Access to Central Avenue is available from Main Avenue through the parking lot of the business complex south of Central Avenue.

Area 7. Businesses adjacent to Butterfield on the West side Between E Central and Main Avenues

Access and egress will only be available off Main Avenue and through the parking lot.

Area 8. Area North of Main Avenue Between Butterfield and Highway 101 (Including El Toro Elementary)

Egress will be available via Butterfield between Central Avenue and Jarvis Drive. Those wishing to access the area during the closure will have limited access available from the south from Diana Road and then north on Grand Prix Avenue (City staff will manage limited crossings of Main at Grand Prix Ave).

Special notes: Laurel Road residents will have limited controlled access to travel between Serene Dr and Laurel Road on Main Avenue during the closure, utilizing road shoulder. Valley Pines and nearby residents on the north side of Main Avenue will be able to access and egress via Grand Prix Way North.

Area 9. Area South of Main Avenue Between Diana Ave, Butterfield Boulevard and Highway 101

Residents will have access and egress via Diana Avenue.

Special notes: Residents on Carriage Lamp Way will be required to utilize back gate off Bel Air Court.

Area 10. Main Avenue East of Condit Road (including Live Oak High School)

All access and egress shall be via Main Avenue East to Elm Road or Hill Road.

Area 11. Condit Road Between Main and Dunne Avenue, including:

Rancho Grande De Morgan Hill, residents on Diana west of Condit, South Valley Mushroom Farm, Ford Store, La Quinta, Holiday Inn Express, McDonalds, Jack in the Box, and Rat's Petrol

There will be no ingress and egress during the course closure. Limited egress may be allowed via approval of course marshals.

Area 12. Businesses and Residences between Condit and Murphy Avenue

Access and egress via Murphy Avenue.

Area 13. Businesses on Condit Between Dunne Avenue and the Morgan Hill Aquatics Center, including:

Carls Jr, Norcal Kenworth, Pan Pacific RV, California Inn, and Executive Inn.

There will be no ingress and egress during the course closure. Limited egress may be allowed via approval of course marshals to San Pedro or Tennant Avenue.

Area 14. Businesses on Condit Between the Morgan Hill Aquatics Center and Tennant Avenue, including:

Microtel, Comfort Inn, House of Thunder, Patio World, and Hampton Inn.

Access and egress via Condit Road south to Tennant Avenue.
